Vacancy

Union Representation

Pairing Optimizer Update

On January 4th J.P. Nault, our Local PBS Rep and I along with members of the Component and the Component PBS Committee attended a demonstration of the new pairing optimizer presented by Navitaire, the pairing optimizer vendor and Air Canada. We were given a brief overview of how the optimizer works. For the initial phase standard costs will be optimized such as deadhead, trip hour guarantee, duty period guarantee etc. In the near future meal allowances and hotels will also be optimized. This issue is still ongoing and we will continue to monitor the impact of the new pairing optimizer and any violations to our collective agreement.
