Here we go again...

Just a reminder that as the 2016 fades away, a new tax year begins in 2017. You will see full CPP, EI and income tax deductions on your advance and your pay. You may have noticed an increase in your income during the last few months of 2016, as you may have already reached the maximum contribution level for some federally mandated deductions. Each year, the Government sets a maximum deduction amount, meaning, you contribute at the percentage rates until you reach the maximum, then no further deductions are made. But as a new year starts, these deductions will recommence. Both the rates and the maximum contribution levels have changed for 2017. 1.65 % is the new rate for Employment Insurance up to a max of \$836.19 and it is 4.95% for the Canada Pension Plan up to a max of \$2564.10.

Waiting for Money

On the first of every month, we receive a monthly 'advance.' If the first falls on a weekend or holiday, the advance is paid the business day *prior* to the first. January is always the exception. For tax purposes, the deposit must take place in the 2017 year, so the advance will be paid the first business day *after* January 1. This year, January 1 is a Sunday, which means banks and businesses will also have Monday, January 2 as a day off in lieu. This means that you should not expect a deposit until Tuesday, January 3, 2017. Plan accordingly to avoid overdraft fees.
