### Mat. Alt. Widebody Pay

If you are a service director working ground maternity alternate duties and you shadow bid and are able to hold wide body flying, this rate should be incorporated into the calculation of your daily rate. If you feel that you are not being paid correctly and cannot get it resolved directly with the Company yourself, bring copies of your PBS block, ground work time sheets, pay summary and pay statements to us and we will investigate further for you.

### Voluntary Extension Banks have been cleared

Unused credits left in your voluntary extension time bank were paid out as of April 30 and your time bank has been cleared. If you intend to use this feature of our Collective Agreement, you need to operate a flight on voluntary extension to replenish your bank for the rest of the year until April 30 2020. Also, if you were on reserve in April 2019, check your pay statements to ensure that you were paid correctly for your time bank and any minimum guarantee (if applicable.)

#### PLOA

Asking for a leave of absence? Be aware that if you ask for a personal leave of absence from a pairing or set of reserve days, your absence will continue until your next pairing or set of C or R reserve days. During this period you will not be allowed to pick up another pairing on VE or trip trade. Depending on how long the stretch of days off are, this leave can substantially affect your minimum guarantee. We remind reserve crew members that instead of a personal leave of absence, you can request a release. If you request a release and are denied but subsequently offered a leave, please let us know by emailing office @local4092.ca.

## Injury on Duty

Injured on duty? Did you know that if you email <a href="mijury@accomponent.ca">injury@accomponent.ca</a> you will immediately receive a bounce back email detailing the process for reporting an injury at work, including the forms needed to apply for WSIB. The message is in both English and French and contains information for all bases, as WSIB can be different depending on what province you reside in.

### No Cuts to Education

On March 15, 2019, The Ford Government laid out a plan to cut millions of dollars from public education. They will do this by increasing class sizes from Grades 4 - 12, removing special education funding, and requiring all high school students to take four online courses.

This destructive plan will pull thousands of teachers and support staff out of our schools, providing less individual support for students, reduced access to student courses and
